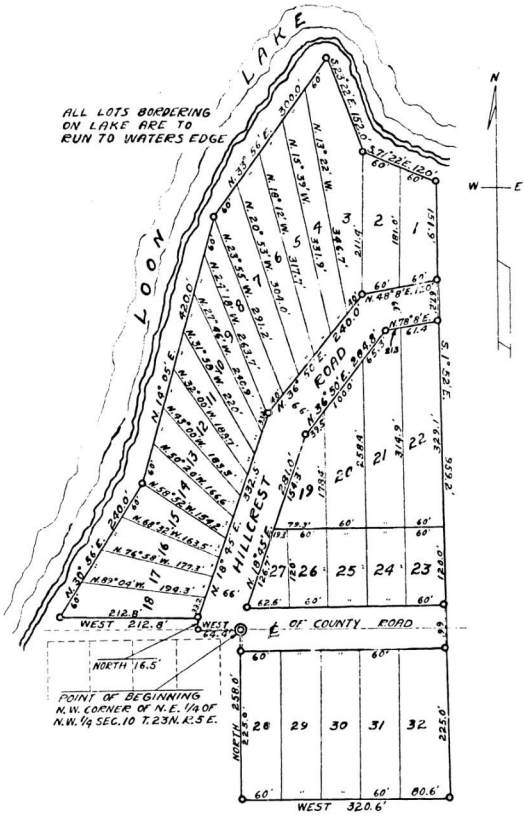
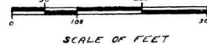


BLUE WATER BLUFF'S

DESCRIPTION OF LAND PLATTED
The land embraced in the annexed plat of "Blue Water Bluff's". A Subdivision of part of Gov't Lot 5, Sec. 3, and part of the NE 1/4 of the NW 1/4 Sec. 10, T. 23 N. R. 5 E., Plainfield Twp., Iosco County, Michigan, is described as follows:

Beginning at the NW corner of the NE 1/4 of the NW 1/4, Sec. 10, T. 23 N. R. 5 E., Iosco County, Michigan; Running thence West 64.4 ft., thence North 145.1 ft., thence West 212.8 ft., thence N. 30° 56' E. 240 ft., thence N. 14° 05' E. 420 ft., thence N. 33° 56' E. 300.0 ft., thence S. 23° 22' E. 152.0 ft., thence S. 71° 22' E. 120.0 ft., thence S. 1° 52' E. 959.2 ft., thence West 320.6 ft., thence North 258.0 ft. to the point of beginning.

All dimensions are given in feet and decimals thereof.

SURVEYOR'S CERTIFICATE
I hereby certify that the plat hereon delineated is a correct one and that permanent metal monuments consisting of bars not less than one-half inch in diameter and 48 inches in length, or shorter bars of not less than one-half inch in diameter, lapped over each other at least 6 inches with one end of each bar not less than 48 inches, encased in a concrete cylinder of not less than 4 inches in diameter and 48 inches in depth have been placed at points marked thus (O) as thereon shown at all angles in the boundaries of the land platted, or at the intersections of streets, intersections of alleys, or of streets and alleys, and at the intersections of streets and alleys with the boundaries of the plat as shown on said plat.
