
DESCRIPTION OF LAND PLATED

The land embraced in the annexed plat of Cowans Bass Lake Subdivision Plainfield Township, Iosco County, Michigan, is described as being a part of the East half of the South-west quarter NW of section 18, Township 7, Range 12, Iosco County, Michigan, and a part of the West half of the South-west quarter NW of section 19, Township 7, Range 12, Iosco County, Michigan, and a part of the South half of the South-east quarter SW of section 19, Township 7, Range 12, Iosco County, Michigan, all particularly described as follows to wit: Commencing at a point 33 feet north of the corner of the South half of the South-east quarter SW of section 19, Township 7, Range 12, Iosco County, Michigan, running due west 40 feet, thence north 33° east 100 feet, thence north 5° east 394 feet, thence north 55° west 35 feet, thence north 65° east 45 feet, thence north 5° east 100 feet, thence north 33° east 100 feet, thence south 76° 06' east 168 feet, thence north 50° 42' east 100 feet, thence north 5° east 100 feet, thence north 55° east 221 feet, thence north 30° 50' east 119 feet, thence east 100 feet, thence south 50° 42' west 100 feet, thence north 55° east 100 feet, thence south 35° 45' west 100 feet, thence south 50° 42' west 100 feet, thence south 35° 45' east 100 feet, thence south 50° 42' west 100 feet; thence south 43° east 783 feet, thence south 35° 45' west 100 feet, thence north 75° 45' west 100 feet, thence south 35° 45' west 957 feet to place of beginning.
