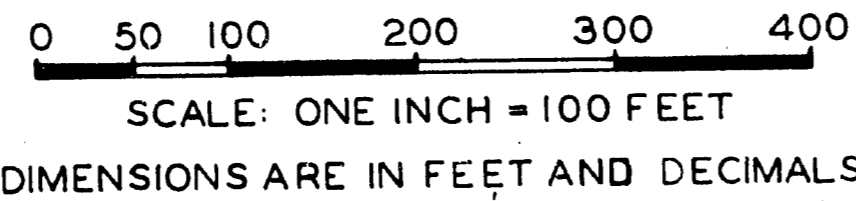

DESCRIPTION OF LAND PLATTED

This subdivision contains Lots 1 to 22, inclusive.
