DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of Supervisor's Plat of First Addition to JOSE LAKE RESORT a subdivision of Government Lot 3 and part of Government Lot 2 section 16 T24N R5E Plainfield Township Iosco County, Michigan is described as follows: Beginning at the 1/4 corner common to sections 9 and 16 T24N R5E thence N 87° 45' W 1310.45 feet, thence S 2° 11' W 1305.31 feet, thence S 87° 01' E 1312.19 feet, thence N 2° 31' 50" E 288.38 feet, thence N 51° 06' 40" W 330.6 feet, thence N 63° 17' 10" W 235.2 feet, thence N 24° 38' 40" W 512.56 feet, thence N 17° 20' 20" E 127.3 feet, thence N 48° 33' 20" E 158.5 feet, thence N 74° 28' 20" E 139.52 feet, thence S 88° 43' 40" E 428 feet to point of beginning.

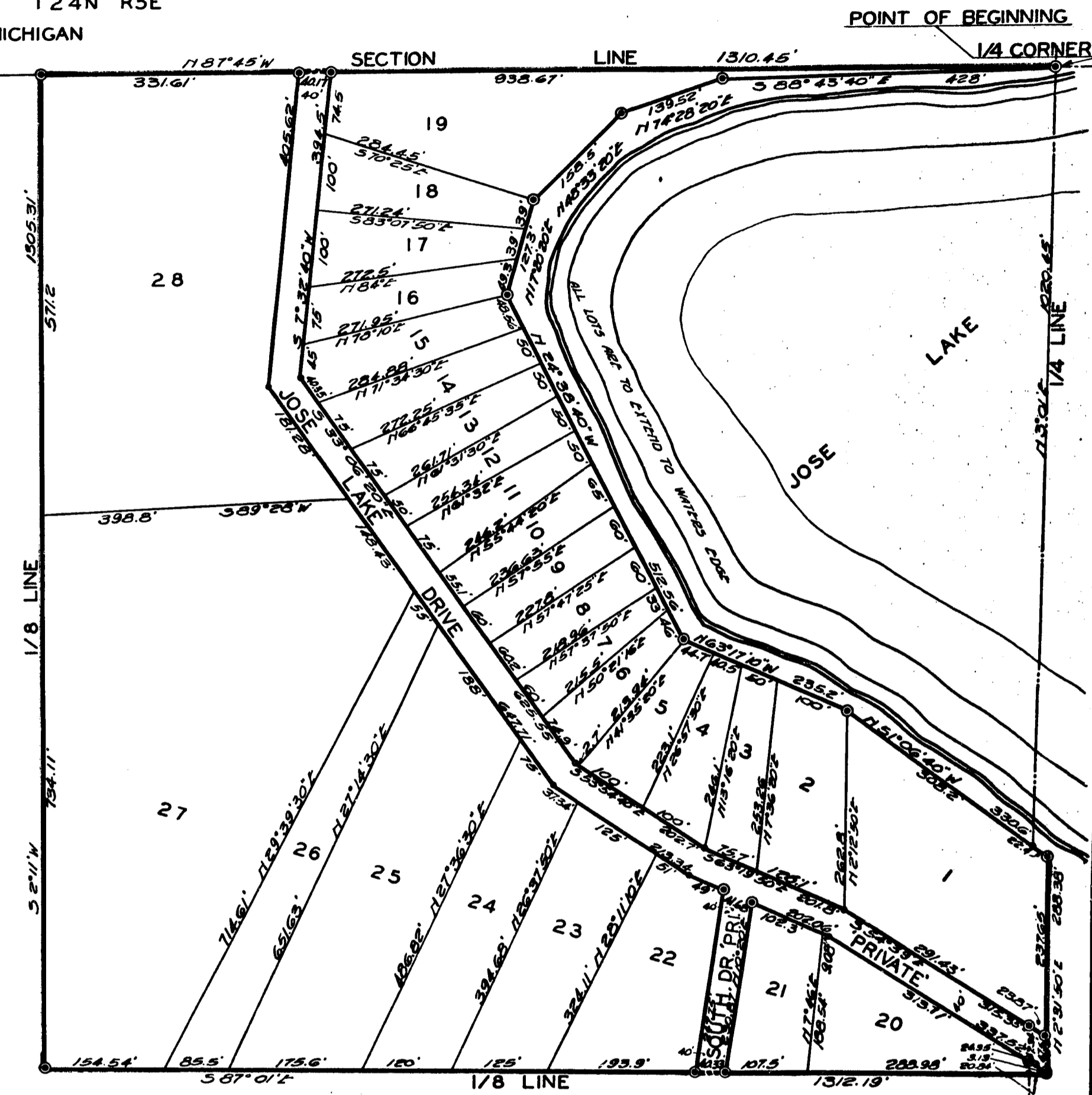

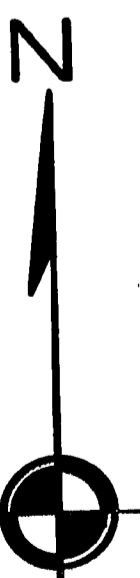
