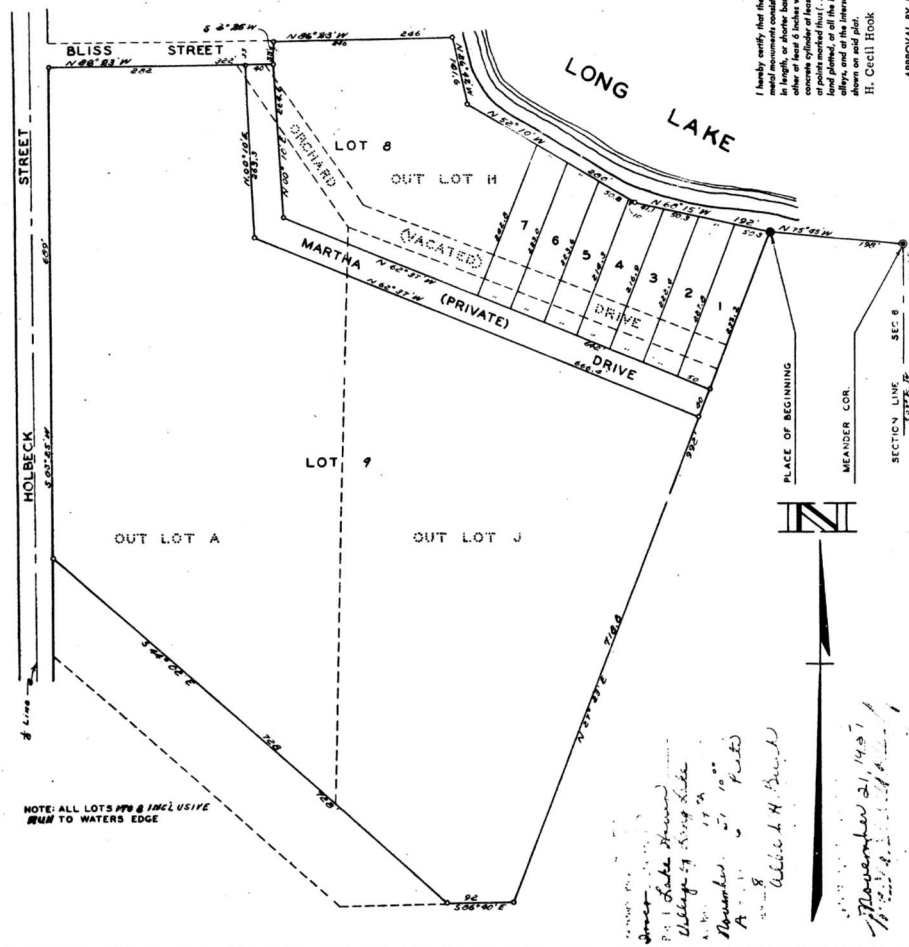


**LAKE HAVEN**
