

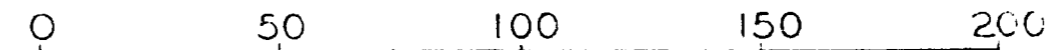
DEDICATION

This replat contains lots 9 through 13.
